

Healthy Shasta Golden Shoe Scavenger Hunt
Official Rules and Release of Liability and Eligibility – October 2008

- 1. Eligibility:** The Healthy Shasta Golden Shoe Scavenger Hunt is open only to legal residents of Shasta County and individuals who work or go to school in Shasta County. Minors must have a parent or legal guardian sign to claim a prize. Participants of Healthy Shasta's committees, including the partnership leadership team, steering, media, and event committees, and their immediate families are excluded from winning a prize. By participating, entrant unconditionally agrees to and accepts these Official Rules and the decisions of the Golden Shoe sponsors.
- 2. Contest period:** The Healthy Shasta Golden Shoes will be hidden throughout Shasta County between September 15, 2008 and October 4, 2008. Shoes must be submitted to an official drop-off site by 5 pm on October 10, 2008. Official drop-off sites are the regional and Redding Public Health Offices and at the Healthy Shasta Walk This Way at Turtle Bay event on October 4th.
- 3. How to participate in the Healthy Shasta Golden Shoe Scavenger Hunt:** There will be 5-7 golden shoes hidden throughout Shasta County in locations associated with a physical activity or healthy foods. A person that finds an official golden shoe and brings it to an official drop-off site will win the prize associated with that shoe. Each shoe will be tagged with a number and directions of how to claim the prize.
- 4. Requirements of winners:** In order to claim the prize associated with a particular shoe, the potential winner (or parent/legal guardian if person is a minor) will be required to sign and return an affidavit of official rules and release of liability and eligibility. No prize will be awarded unless the Golden Shoe and a signed and completed Official Rules and Release of Liability and Eligibility form is turned into an official drop off site by October 10, 2008.
- 5. Prizes:** Each Golden Shoe is associated with a prize worth \$200 or more. The prizes include: 1-year YMCA family membership (\$650 value), Fleet Feet Sports gift certificate (\$200 value), Sunset Marketplace gift certificate (\$200 value), Water Fun package which includes a 2009 Redding Aquatics Center Family Pass, plus various outdoor items donated by the City of Redding Recreation Department (\$200 value), Redding Certified Farmers Market gift certificate donated by Simpson University (\$200 value), \$300 toward a bicycle or bicycles of your choice at a local bike shop donated by Mercy Medical Center (\$300 value), Churn Creek Meadow Organic Farm gift certificate for fresh produce deliveries to your home or office donated by Slow Food (\$200 value), 2 Sports Scholarships to use towards karate, gymnastics, swimming lessons, dance classes, basketball registration or another physical activity class/program donated by the Active 20-30 Club and by Redding Rancheria (\$200 value each), and 6-month Curves membership (\$200 value). There is a limit of 1 prize per person. Any taxes or additional costs associated with the prize are the responsibility of the recipient.
- 6. Publicity:** Except where prohibited, claiming the prize associated with a Golden Shoe constitutes irrevocable consent to the Healthy Shasta partners including but not limited to: County of Shasta, City of Redding, YMCA, McConnell Foundation, Turtle Bay Exploration Park, Shasta County Public Health, First 5 Shasta, Mercy Medical Center, Redding Rancheria, Simpson University, Shasta College and its agents to use, reproduce, publish, display, and distribute, the names, likeness, quotations, opinions and biographical information of the person claiming the prize, including without limitation, any photograph, statement or recording for promotional purposes in any media, worldwide, without further payment or consideration to any person or entity including, but not limited to, his or her successors or assignees. Names of winners will be posted at www.healthyshasta.org.
- 7. Release and Limitations of Liability:** In consideration for participating in the Healthy Shasta Golden Shoe Contest and claiming a prize from the contest, the undersigned or his or her parents or legal guardian(s), to the fullest extent permitted by law, release and hold harmless Healthy Shasta, and their officers, affiliates, employees, volunteers, and agents from any and all liability for any injuries, loss or damage of any kind arising from or in connection with the Healthy Shasta Golden Shoe Contest or receipt or use and/or misuse of any prize including, but not limited to any injury, death, or damage to or loss of personal property arising out of, or in connection with, finding or searching for a Golden Shoe, claiming a prize associated with a Golden Shoe, or use

and/or misuse of any prize awarded as part of the Healthy Shasta Golden Shoe Contest Entry, from whatever cause including the active or passive negligence of Healthy Shasta except for injury, death, damage to or loss of personal property arising from the established sole willful misconduct of Healthy Shasta.
